2. HAZARDS IDENTIFICATION

Main hazards: Very toxic to aquatic organisms, may cause long-term adverse effects in the aquatic environment.

4. FIRST AID MEASURES (SYMPTOMS)

Skin contact: There may be mild irritation at the site of contact.

Ingestion: There may be irritation of the throat.
